**Statement of Work
for
Disaster Recovery – Travel Trailer Purchase**

Purpose. The Federal Emergency Management Agency (FEMA) has a need to purchase travel trailers to be used as temporary housing for disaster victims. The purpose of this Indefinite Delivery Indefinite Quantity (IDIQ) contract is to purchase them and have them delivered to a central staging site(s) as identified on individual delivery orders. The Government reserves the right to award more than one contract. The following are the general requirements for the homes to be procured:

1. All travel trailers shall be constructed in accordance with industry standard practices and all applicable codes and regulations for the states to which they are delivered.
2. All travel trailers shall be standard production models, less any options except as noted. All units shall be of quality normally provided to private sector buyers. All supplies, appliances, and furnishings must be new and current models.
3. All travel trailers shall be eight feet (8') wide and shall not be less than 28' long, but not more than 32' in length.
4. All travel trailers shall be configured to sleep two adults and four children.
5. All travel trailers shall have at least one private bedroom area.
6. All travel trailers shall be complete with furnishings and appliances, the quality of which shall not exceed that which is considered to be industry standard, with no upgrades.
7. Kitchen area shall have built-in cabinets, sink, stove and refrigerator.
8. All delivered units shall be similarly constructed to allow for uniform placement of utility connections.
9. Each travel trailer provided shall be equipped with the following:
 - A roof mounted air conditioning unit.
 - Factory installed entry steps.
 - A fifty foot (50') power supply cord (instead of the standard 25' cord).
 - A smoke detector and a two pound (2 lb.) fire extinguisher.
 - Five (5) packets of chemical for treatment of sewage holding tank.
 - stabilizer jacks.
10. Units must carry standard (12 month) warranties for material and workmanship that are transferable to new owner within the warranty period.
11. Travel trailers shall be ready for occupancy upon delivery.

Award of Contract and Area of Coverage. Travel trailers may be required in any of the following states: Florida, Georgia, North Carolina, South Carolina, or Virginia. The minimum number of travel trailers for the base year is identified on the bid schedule and the same numbers will apply for any option year(s) if awarded. The Contractor shall perform all work and furnish any or all labor, materials and incidentals required to deliver the units to a central staging area in the disaster area, within the times specified in the delivery orders.

Delivery.

a. Orders. Orders may be issued in writing; by electronic communication; by telephone; by facsimile; or orally, with written confirmation. Delivery of first units on initial delivery order will be required within 2 working days after receipt of delivery order. Subsequent delivery orders will require first delivery within 5 working days of the order.

b. Quantity. For each mission, delivery orders will be issued for quantities as needed for the mission. Exact quantities and delivery schedules will be identified on the delivery order(s).

c. Delivery Requirements. A Contracting Officer's Representative shall inspect the units at the staging site before signing for receipt of the units. The Contractor must use licensed drivers and tractors in proper and safe operating condition for the general public and the drivers. Each delivery ticket shall contain the following minimum information:

- Contractor's Name.
- Contract Number.
- Delivery Order Number.
- The Manufacturer's Identification number of the unit(s).
- Quantity, Unit Price, and Extended Price of Items (Unit prices and extensions need not be shown on delivery ticket when incompatible with the use of automated systems; however the invoices must be itemized to show this information.).
- Date and Time of Delivery.
- 24-Hour Point of Contact including Phone and Fax Numbers.

Measurement and Payment.

a. Unit Pricing. Cost identified on the Schedule of Supplies and/or Services and Prices, Item "Travel Trailer" shall include all labor and material necessary to manufacture the unit, furnish it and deliver it to a destination as part of the Travel Trailer line item to include all manufacturer's Owners Manuals, warranties. The Contractor shall include the cost of material and labor for blocking or chucking the unit at the delivery site and stabilization of the unit. Temporary setup shall consist of blocking the tires to prevent accidental movement, and jacking and support of the hauling tongue of the trailer by secure means. The temporary setup shall also include up to four hours of standby time for the driver.

b. Standby Time. Standby time, in excess of four hours, for each tractor/truck with a travel trailer shall be paid in accordance with the Schedule of Supplies and/or Services and Prices, Item "Standby Time in Excess of 4 Hours." When unloading is not completed within four hours of delivery, and the delay is not from the fault or negligence of the Contractor or its agents, the Contractor shall be entitled to a maximum of ten hours per calendar day of standby time. No other payment will be made for standby time. The Contractor shall document its entitlement to standby time, by directing its delivery personnel to sign-in and sign-out with the Government's on-site representative at each arrival and departure from the delivery site. These records will be used to determine the amount of standby time. The amount, if any, to be paid, will be determined by rounding the recorded time to the nearest hour. No standby time shall be

paid for convoy lead or trail pickup trucks sometimes used to designate wide or slow moving vehicles.

c. Additional Ground Mileage. It is anticipated that delivery orders will require deliveries to locations in addition to the delivery locations specified in the Schedule of Supplies and/or Services. This additional ground mileage, in excess of 100 miles, will be paid for based on the total mileage between the point of origin of the trailer and the destination specified in the delivery order. The price per mile shall be for each travel trailer delivered. The mileage shall be computed using Army Regulation 55-60, Transportation and Travel, Official Table of Distances, Continental United States, Alaska, Hawaii, Canada, Canal Zone Central America, Mexico and Puerto Rico, dated December 1981, or edition current at date of bid opening. No per diem will be paid for delivery.

d. Misdirected. In the event a delivery location is changed after an order is issued, payment for that transportation shall be accordance with the Schedule, item "Mileage".

e. Blocking Materials. The Contractor shall include the cost of material and labor for blocking or chucking the unit at the delivery site and stabilization of the unit.

(g) Contract award (not applicable to Invitation for Bids). The Government intends to evaluate offers and award a contract without discussions with offerors. Therefore, the offeror's initial offer should contain the offeror's best terms from a price and technical standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary. The Government may reject any or all offers if such action is in the public interest; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

YEAR 2000 COMPLIANCE (FAR 39.106) (JUL 1998)

The contractor shall ensure that, with respect to any design, construction, goods, or services under this contract as well as any subsequent task/delivery orders issued under this contract (if applicable), all information technology contained therein shall be Year 2000 compliant. Specifically, the contractor shall perform, maintain, and provide an inventory of all major components to include structures, equipment, items, parts, and furnishings under this contract and each task/delivery order which may be affected by the Year 2000 compliance requirement.

"Year 2000 compliant" means that such information technology shall

accurately process date/time data (including, but not limited to, calculating, comparing and sequencing) from, into and between the twentieth and twenty-first centuries, the years 1999 and 2000, and leap year calculations. Furthermore, "year 2000 compliant" information technology, when used in combination with other information technology, shall accurately process date/time data if the other information technology properly exchanges date/time with it.
